Nomination by Petition

As per the bylaws of FAA Federal Credit Union (FAAFCU), notice is hereby given that nominations for board vacancies may also be made by petition signed by 1% of the voting members with a minimum of 20 and a maximum of 500. All nominees made by petition must submit concurrently a brief statement of qualifications and a signed agreement, in a form acceptable to the board, stating both their willingness to be nominated and to serve if elected. Nominations by petition will be closed as of February 11, 2026.

The election will be held by electronic device as outlined in the FAAFCU bylaws. Additionally, the election will not be conducted by ballot and there will be no nominations from the floor when the number of nominees equals the number of positions to be filled.

TENNESSEE CREDIT UNION LEAGUE PROVIDES \$40,000 IN FREE GROCERIES STATEWIDE
